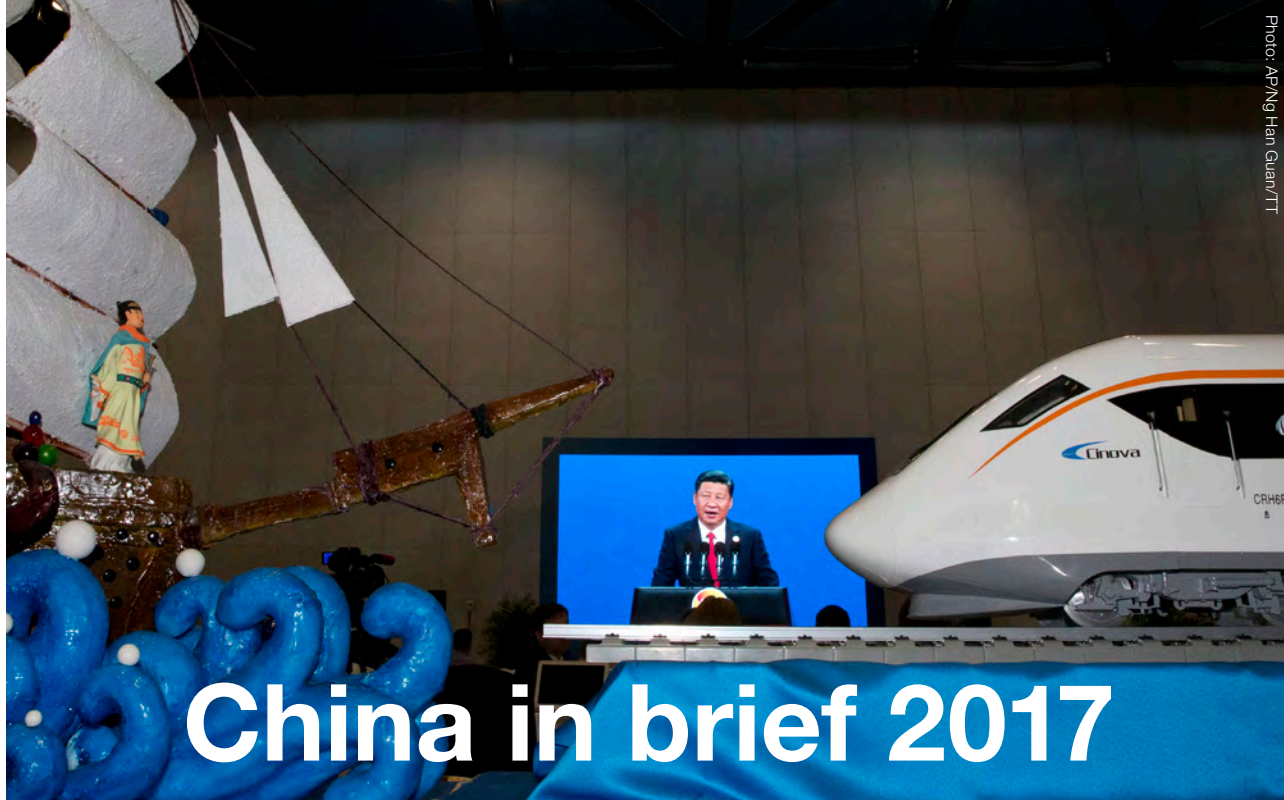

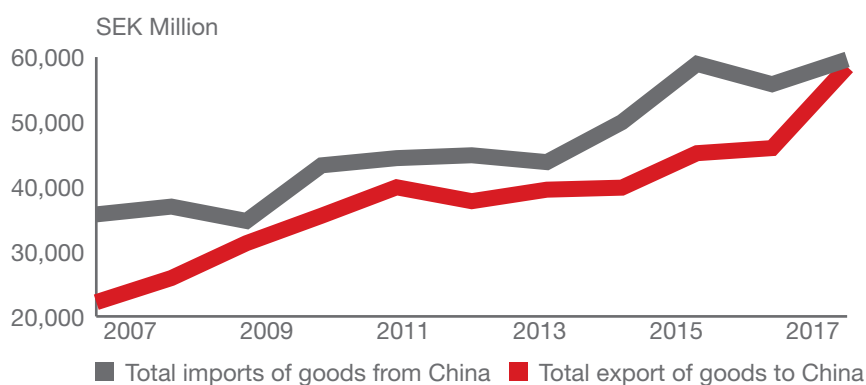
# China in brief 2017

- China's economy grew by 6.9 per cent during 2017, ending the year on a positive note as official figures topped the government target of 6.5 per cent. This is the first time in seven years the pace of growth has picked up. China's total trade reached USD4,104.5 billion with export increasing by 7.9 per cent and imports increased by 15.9 per cent.
- "China and the EU are contributors and beneficiaries of world multi-polarization and process of economic globalization, and under the current situation, China and the EU should confront the instability of the international situation with a stable bilateral cooperation" Premier Li Keqiang, China-European Union (EU) Summit in Brussels in June 2017.
- In October, the 19th Party Congress was held in Beijing with 2,280 delegates representing the party's estimated 89 million members. The Party Congress, held every 5th year, saw Xi Jinping further consolidate his power, with his name inserted into the party's constitution, an honour no Chinese leader has enjoyed while still in power since Mao Zedong.
- The China – US relationship during 2017 was a trade war that never materialized. Predications are that 2018 could be a totally different story.
- "I expect a trade war to emerge in the first part of the year, and it could spiral into a serious conflict that threatens other elements of the relationship," said Scott Kennedy, director of the Project on Chinese Business and Political Economy at the Center for Strategic and International Studies.
- Chinese investments globally is slowing down for the first time since 2006 with a few exceptions among them Sweden being one. The Chinese FDI into Sweden during 2017 was USD1.4 billion compared to USD100 million during 2016. The slowing overall figures is mainly driven by Chinese policies restricting outbound investment. A record proportion of cancelled deals globally were blocked by foreign regulators.
- In May, President Xi Jinping hosted the Belt and Road Summit in Beijing, attended by world leaders and top officials, to bolster China's global leadership ambitions. Sweden was represented at the Forum by the then Minister for Infrastructure, Ms Anna Johansson.

## Sweden's trade with China

Exports of goods to China from Sweden increased 27 percent in 2017. The total value of exported goods was SEK 58,506 million in 2017 compared to SEK 45,959 million in 2016. Imports from China increased by 7 percent in 2017 and the value of goods imports was SEK 59,626 million during the year, the figure in 2016 was SEK 55,806 million. China is Sweden's biggest trading partner in Asia.

# Team Sweden Kina

**Since late spring 2017** SCTC is, by invitation from the Ministry for Foreign Affairs, represented on Team Sweden Kina, represented by Secretary General Elisabet Söderström, vice-chairman Frédéric Cho and chairman Thomas Lagervist. Team Sweden Kina, TSK, is a working group within the framework of the current government's export strategy initiated by State Secretary Oscar Stenström. The purpose of TSK is to improve the coordination of the business promotion that is being carried out by both public and business interests. The ultimate goal is of course to increase business exchange with China, which is also consistent with SCTC's vision to increase more concrete business for our members between Sweden and China, with reduced risk.

Team Sweden Kina had three meetings in 2017. Although slowly, progress is being made and we have received clear and written evidence that SCTC's business perspectives combined with the state-of-the-art knowledge and experience about China is being valued and our engagement has led to a more effective and business oriented focus in the coordination of various export promotion activities carried out by the various ministries and government agencies.

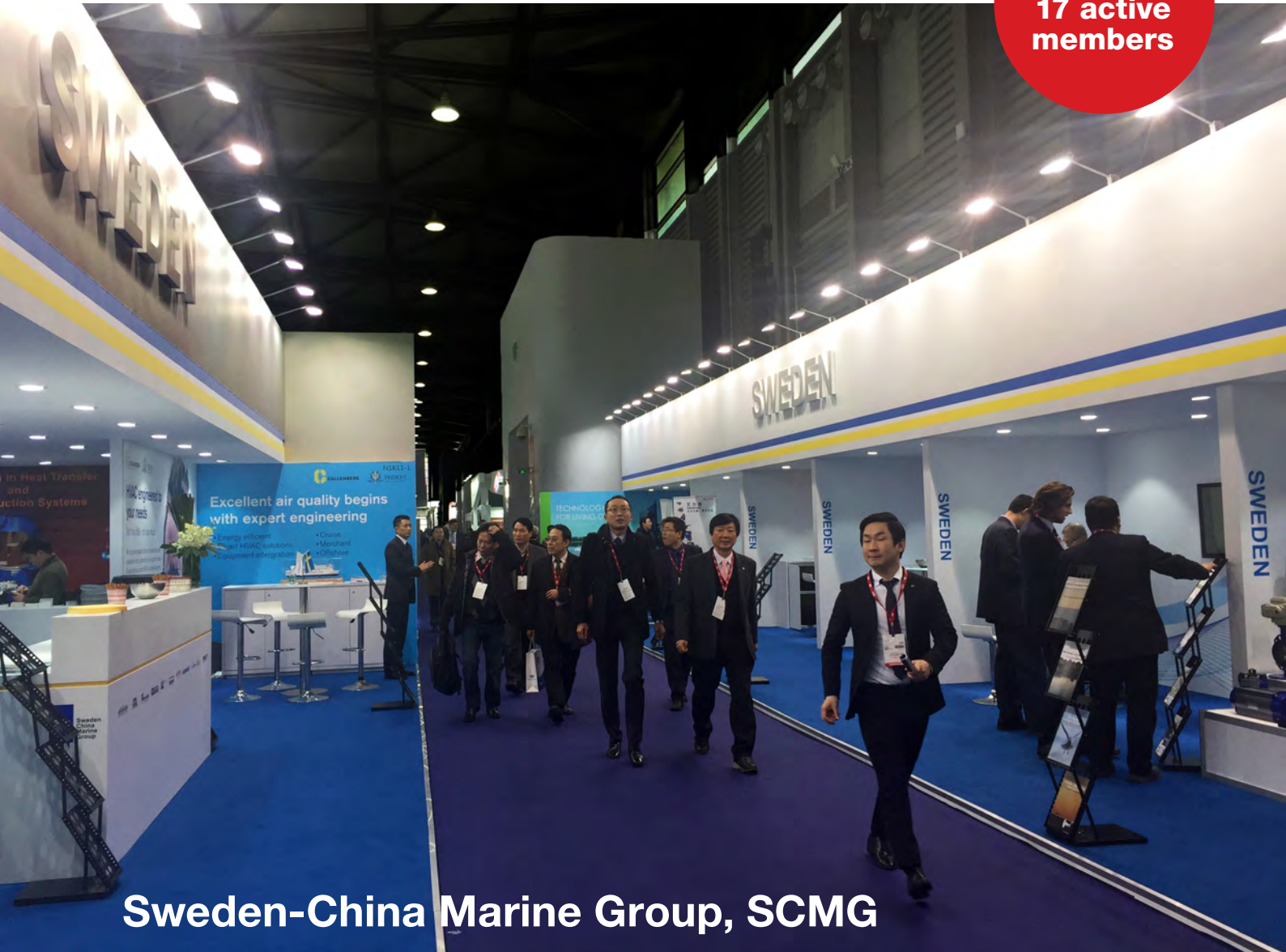
# Working Groups

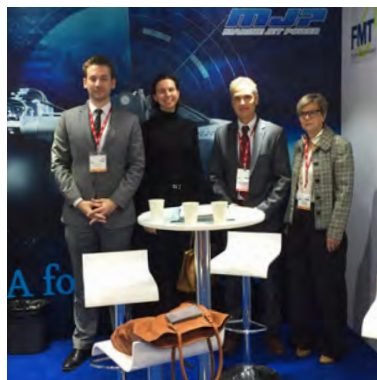

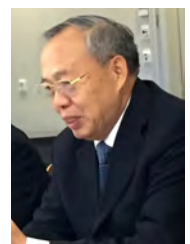

## Board Meetings

In 2017, altogether five Board Meetings were held, one in Gothenburg and four in Stockholm.

During the Board Meetings, less than 15 per cent of the time is spent on reports from individual Board Members and the Secretary General. Remaining time is spent on analysing China and discuss-

ing how SCTC shall be best equipped to address the various challenges that our members are facing. Time is also and always spent on analysing if SCTC is serving its members in a relevant and effective way and on discussing how to attract new members.

## Executive Board

**The Executive Board** consists of the Secretary General, the Chairperson and the current three Vice-Chairs. The purpose is to act as a sounding board and support function for the Secretary General in the daily operations as well as an executive body in case quick decisions need to be made in the operations. Decisions made by the Executive Board are always reported to the next ordinary

Board Meeting and, where required, formally confirmed by the Board.

Each of the members of the Executive Board are also frequently engaged in representing SCTC in various official events, thereby supporting the Secretary General in what would otherwise be an impossible workload for a one-person administrative office.

## Committee meetings

**SCTC currently has four committees:**

- Membership Committee;
- Program & Editorial Committee;
- Opinion Committee;
- Public Affairs Committee

Each committee is chaired by a Director of the Board to ensure total transparency for the Board in the committee activities, because the Board is responsible and accountable to decisions made by the committees.

The Opinion Committee is active on and off depending on whether there is a particular issue that SCTC needs to have an official position on. Currently the Committee is active again and preparing SCTC's position on a more assertive China and how to deal with that on different levels relevant to members business activities in and with China.

The Public Affairs Committee consists of Swedish municipalities, towns and regions that have entered into twin-city

agreements with a Chinese party of equal standing and its purpose is to improve the commercial exchange between twin-cities, on a Swedish national level, primarily by mapping industry and business structures for each agreement so as to enable a kind of cross-fertilization that AB Sweden can use for increased business exchange between Sweden and China.

The Program & Editorial Committee meets 5–6 times per year to secure a continuous flow of events and knowledge exchange to the benefit of members and others interested to keep up with the constant flow of China information provided by SCTC.

The Membership Committee is active in generating member-value to existing members as well as attracting new members in different sectors.

**All in all**, SCTC was engaged in more than 35 different activities over the year. On top of that comes all the various meetings we have had with the Swedish Government in its different shapes and forms. 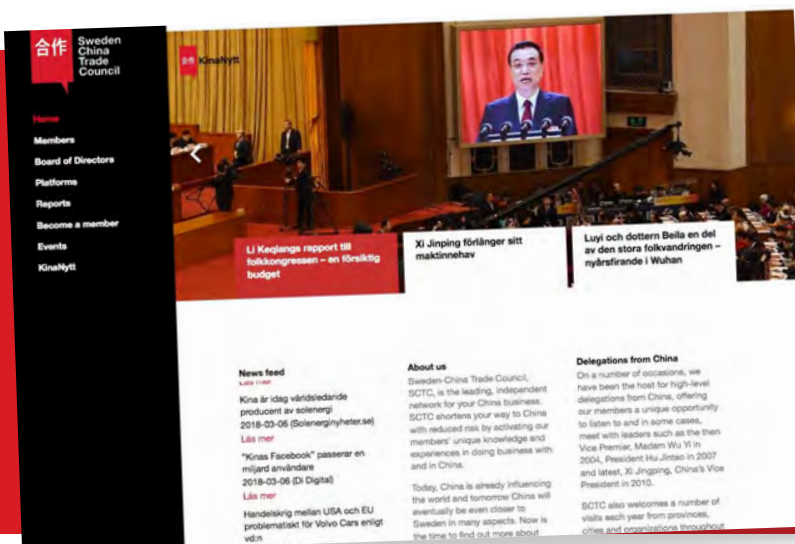
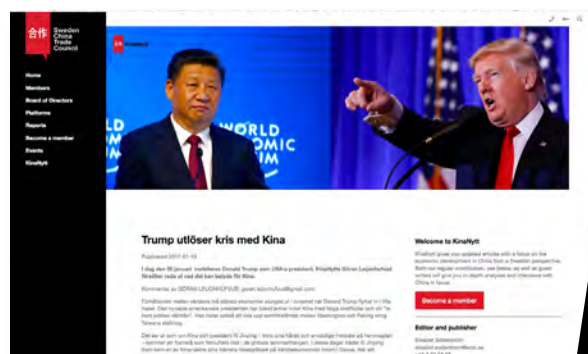
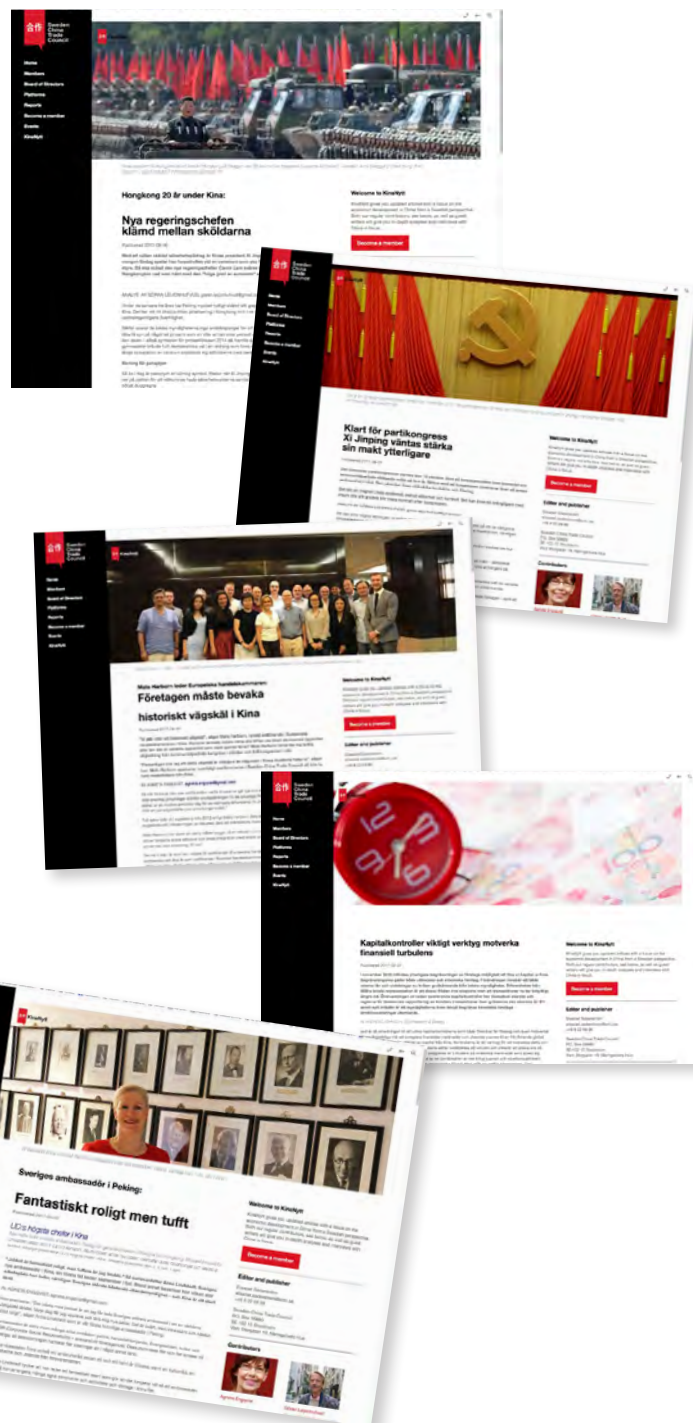
